7-Eleven has negotiated a discounted rate with Dunbar Armored to service the stores at a group rate. The current offering is \$181.00 per month excluding taxes, fuel surcharge, holiday service (45.00), excess liability charges more than five items pick up (\$1.25 per item), over 7 minutes pickup (\$2.00 minimum.). Dunbar will service the stores three times a week Monday, Wednesday and Friday to pick up the deposits and stores can also order the change fund which will be brought directly to the stores by Dunbar.

Participation Agreement

Definitions:

"Delivery Location" means the location designated by 7-Eleven as the place where Dunbar is to deliver Shipments. The bank or night depository designated by 7-Eleven for your Store is the Delivery Location.

"Distinctively and Securely Sealed" means that the container used to hold any Property to be transported by Dunbar has been closed and fastened with a device or method of sealing having a distinguished mark that can be clearly seen and recognized as a unique identification number or special mark that is attached to the container so that the Property is enclosed and firmly fixed therein, and the device or method of sealing cannot be removed or reapplied to the container without leaving visible external evidence of tampering to the container.

"Loss" means any loss of, damage or destruction of Property.

"Pick Up Location" means the location designated as the place where Dunbar is to call for Shipments. Your Store is the designated Pick Up Location.

"Property" means currency, coin, checks, securities, and other financial instruments, and other valuables as mutually agreed upon with Dunbar.

"Shipment" means one or more sealed containers of Property received by Dunbar as the same time at a single Pick Up Location, that are to be delivered to a single Delivery Location.

Services:

Dunbar Armored Inc. ("Dunbar") shall provide the following services (collectively the "Services"):

ARMORED TRANSPORTATION AND RELATED SERVICES. Dunbar shall on, Tuesday and Thursday and Saturday of each week: (1) call for Shipments said to contain Property at the Pick Up Location (2) give a receipt for Shipments received by Dunbar; and (3) deliver such Shipments in like condition to the Delivery Location and obtain a receipt for such delivery.

The Services will be performed during Dunbar regular business hours as scheduled by Dunbar at the time its regular route is in the immediate area of the Pick Up Location and Delivery Location. In the event of inclement weather or some other irregularity, performance shall be as mutually agreed upon.

Your Responsibilities:

You shall prepare all Property to be delivered to Dunbar in Distinctively and Securely Sealed containers.

You shall declare the actual value of each Shipment transported by Dunbar and you shall not conceal or misrepresent any material fact or circumstances concerning the Property delivered to Dunbar and you agree, in the event of Loss, to be bound by its declaration of value.

Fees for Services: These fees cover Dunbar standard armored transportation and related services as outlined above.

***Monthly Service Fee** for the Services is \$181.00 excluding taxes, fuel surcharges, holiday service (\$45.00), excess liability charges, more than 5 items pickup (\$1.25 per item), over 7 minutes pickup (\$2.00 min.).*

The information above is a general description of the services and rates provided for in the Agreement between 7-Eleven and Dunbar (the "Agreement") as applicable to franchised stores that wish to participate in the Agreement. Upon request, you may review a copy of the Agreement.

By agreeing to the services provided by DUNBAR by signing in the space(s) provided below, you understand that:

- you will be bound by the terms of the Agreement as applicable to franchised stores;
- you authorize 7-Eleven to make payment for the services provided by Dunbar on your behalf; and
- the cost of such services will be charged to your Open Account for the month in which 7-Eleven is invoiced for same.
